Subject: Fall 2019 Schedule and AB 705

Hi Brad, Eddie, and Crystal,

I just got out of meeting with President Buckley. In that meeting, we discussed the conversation he was part of last week with the Chancellor and other college presidents regarding AB 705. There is concern that students will be confused if classes are scheduled in English, math, and learning skills that are not part of the placement sequence. Also, we have a requirement to facilitate enrollment into transfer level English and math. As such, I have been directed by Dr. Buckley, who received direction from the Chancellor as given to all college presidents, to have all English and math classes more than one level below transfer pulled from the fall 2019 schedule. Learning skills is included as it is part of the English sequencing in levels below transfer. This means that all English 21, Math 110, Math 115, and Learning Skills 1/2 classes needed to be removed. Statway is exempted as this is a two-semester sequence to complete transfer level math and is part of the placement model.

I have asked Mary Fellows to not send out offer letters in these areas until you have time to make the necessary schedule adjustments as I know there are some assignments for load and others for seniority. Please be aware that offer letters need to go out this week as per the contract. Therefore, please make the necessary changes by Wednesday, April 17, 2019.
